## INSTALLATION TIPS

- Install vertically with cartridge hanging down
- Never use saddle valve for connection
- Use 3/8" water line
- Allow 2 1/2" (6.35 cm) clearance below the cartridge for easy cartridge replacement
- Flush 4H-L cartridge by running water through filter for three minutes at full flow
- This system must be installed and maintained according to the manufacturer's instructions, including installation and replacement of filter cartridges

## OPERATION TIPS

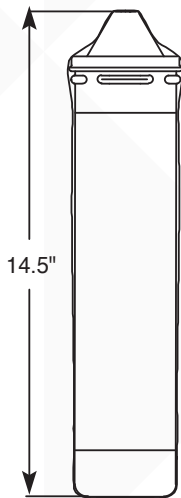
- Replace cartridge once per year or sooner should flow become inconveniently slow
- Change cartridges when capacity is reached or when pressure falls below 10 psi (0.7 bar)
- Service flow rate must not exceed 0.5 gpm (1.9 Lpm)
- Always flush the filter cartridge at time of installation and cartridge change

## SIZING

- Service Flow Rate: 0.5 gpm (1.9 Lpm)
- Rated Capacity: 1,000 gallons (3,780 L)
